## TERMS AND CONDITIONS

### 1. GENERAL

1.1 DEFINITIONS – In the following regulations and conditions, the term “sponsor” describes any company or organization that has made a successful application for the EUCHIS-SIAQ 2017 sponsor item or package. The term “exhibitor” describes any company or organization that has made a successful application for space allocation in exhibition space, or any agent or representative acting on behalf of the exhibitor. The term “organizer” relates to the “EUCHIS SIAQ 2017” ORGANIZING COMMITTEE”.

1.2 ORGANIZERS RIGHT TO AMEND – In its sole discretion the organizer may amend or modify these regulations by posting notice of the amendment(s) or modification(s) on the conference website before the latter shall become effective.

1.3 ANY ASPECT THAT IS NOT COVERED BY THESE REGULATIONS IS SUBJECT TO APPROVAL BY THE ORGANIZER. IF YOUR ORGANIZATION IS CONSIDERING SPONSORING ANY ITEM NOT PRESENTED IN THIS DOCUMENT PLEASE CONTACT US.

1.4 THE SPONSORS CANNOT REPRESENT OTHERS OR PROMOTE OTHERS PRODUCTS WITHOUT THE WRITING PERMISSION OF THE ORGANIZERS.

1.5 THE ORGANIZERS ARE NOT RESPONSIBLE FOR DAMAGE OR LOSS DUE TO FIRE, ACCIDENT, STOLEN OR ANY OTHER CAUSE OF FORCE MAJEURE OR MALPRACTICE.

1.6 TO REDUCE COST, THE ORGANIZERS CAN LIMIT THE NUMBER OF COLORS USED FOR THE IMPRINTING OF THE LOGOS OF THE SPONSORS

1.7 EACH COMPANY IS RESPONSIBLE FOR COMMUNICATING THESE REGULATIONS TO ITS STAFF AND ITS APPOINTED AGENCIES.

## 2. SPONSORSHIP ITEMS AND PACKAGES

2.1 APPLICATION FOR SPONSORSHIP ITEMS AND PACKAGE – Confirmation of request for reservation of a sponsorship item or package is only valid when made in writing by the sponsor to the organizer, by returning a completed and signed Sponsorship Package Application Form and Terms and Conditions (published in this brochure). Once the organizer has accepted the signed application for the sponsorship package, it becomes legally binding for the sponsor. Applications for a sponsorship item or package should be made by April 15<sup>th</sup>, 2017.

2.2 CONFIRMATION OF SPONSORSHIP ITEM OR PACKAGE – Sponsorship package assignments will be made in the order in which application forms are received (FIRST-COME, FIRST-SERVE). The organizer reserves the right to refuse any application that does not comply with the conditions appearing in these regulations. Upon receipt of the signed application form and acceptance of the company or organization as sponsor, the organizer in writing will confirm the sponsorship item or package. The sponsor will provide its logo (in the format required by the organizer) and the details (name, trade names...) within 1 month after acceptance.

2.3 TERMS OF PAYMENT – Upon reservation an invoice for the total due amount in euros shall be sent. Payment is due by 30 days form invoice date.

2.4 CANCELLATION SPONSORSHIP ITEM OR PACKAGES – The sponsor/company cancelling his application for a sponsorship item or package after the official application has been accepted by the Organizing Secretariat, will be liable to pay the following fees. If the package cannot be reallocated to another company:

50% of the total rate, if the cancellation is received in writing before May 15<sup>th</sup>, 2017

100% of the total rate, if the cancellation is received in writing after May 15<sup>th</sup>, 2017

Any refunds will be made after the conference but not later than December 31, 2017. The sponsor will not be entitled to any interest that the organizer may have derived from payments made by the sponsor. All bank charges, including sender's and receiver's charges, resulting from a refund related to cancellation of sponsorship item or package will be at the charge of the sponsor.

## 3. EXHIBITION

3.1 APPLICATION FOR EXHIBITION SPACE – Confirmation of request for reservation of exhibition space is only valid when made in writing by the exhibitor to the organizer by returning a completed and signed Sponsorship Package Application Form and Terms and Conditions (published in this brochure). Once the signed application for exhibition space has been accepted by the organizer, it becomes legally binding for the exhibitor.

3.2 CONFIRMATION OF SPACE ALLOCATION – Space assignments will be made in the order in which application forms are received (FIRST-COME, FIRST-SERVE). The organizer reserves the right of refusing any application that does not comply with the conditions appearing in these regulations.

Upon receipt of the signed application form and acceptance of the company or organization as exhibitor, exhibition space will be confirmed by the organizer in writing.

3.3 TERMS OF PAYMENT – Upon reservation an invoice representing the total amount will be sent by the organizer. Payment, in euros, is due by 30 days from invoice date.
